INSTRUCTIONS

This Written Consent concerns the proposed Amendment to the Declaration of Covenants, Restrictions and Easements for Deer Run (the “Proposed Amendment”). The Proposed Amendment is comprised of 3 changes: (i) adopting the Georgia Property Owners Association Act (“POA Amendment”); (ii) establishing Initiation Fee (“Initiation Fee Amendment”); and (iii) establishing leasing restrictions (“Leasing Amendment”). The Proposed Amendment is enclosed and made a part hereof by this reference. Please review the entirety of the Proposed Amendment to fully understand the proposed changes. Please complete the Written Consent (“Consent”) on the second page of this form to evidence your consent and approval of the Proposed Amendment.

Due to recent Georgia case law, unless the Association adopts and submits to the POA Amendment, there is a question as to whether any new leasing provisions would be applicable to all Owners. Therefore, to eliminate any potential issues in the future, the consents for the proposed Leasing Amendment will only be valid and counted if and to the extent the POA Amendment is adopted and approved by the membership. If the POA Amendment is not approved by the requisite membership consent, all consents for the Leasing Amendment shall be considered null and void. Please note that the Initiation Fee Amendment is independent from the other proposed changes.
